ENTRY REQUIREMENTS

- Please read Calendar of Events
- Multiple Entries per Category Allowed. Fee applies to each entry.
- Categories
 - Acrylics
 - Oils
 - Watercolors
 - Pastels
 - Other Media (pencil drawing, charcoals, pen and inks, block prints, collage, encaustics)
- 90% in one medium to be considered in that category
- Original art only. Jury selections will be based on the review of the original artworks, rather than on slides or jpegs.
- Wired for hanging with frame
- Wrap around frame acceptable
- Wired Frame edge-to-edge **NOT TO EXCEED** 24"H x 24"W
- No saw-tooth/clip hangers
- 5% contribution from artist for art sold. (Art may be marked NFS.)
- Non-refundable¹ entry fee.
 - Early-bird registration fee \$25 per entry, if mail entry form & check by Saturday Oct.15, 2016
 - Otherwise, \$30 after Sat. Oct. 15, 2016

Liability: All reasonable care and safety will be exercised in the handling, hanging, and storing of the art submitted. The Friends of the Agawam Public Library, the Library, and the town of Agawam will not be responsible for loss or damage to any item submitted.
